The Belgian Federal Government Debt amounted to EUR 347.00 billion as of 30 June 2011. Debt issued or taken over by the federal government amounted to EUR 346.60 billion and the institutions for which the federal government supports the debt service registered a debt of EUR 0.41 billion.
